Aldi proposal and Zoning – Update – Holly Petsos

Holly spoke with the city regarding status of lawsuit originated by RERAD, TOPS and 4 individuals. Paperwork sent Jan. 17th, now in hands of the judge who can rule about the facts, testimony, etc., zoning reports, code. No timeline for a judgment.

Another zoning issue discussion: Two houses were recently demolished behind Merwin's Auto, the property owner. They want to expand the repair business. Holly spoke with Merwin Auto's owner and invited him to meet with NVW and BNA to present his plans for discussion. Holly says plan is for a two-story building with convenience store and 6 car repair bays Current zoning is C2. Holly suggests BNA should partner with NWV after a zoning board proposal is submitted.

 - Linda donated cookies left over from a holiday party to Pinny Cooke House in name of the BNA. The residents are required to do 5 hours per week volunteer work in community and we will continue to invite them to help with the Rose Garden.

 - Discussion of how it should be used so enough info gets out without overwhelming people.
- Gaslight Crier delivery. Tom Argust on Gaslight was delivering to half the street and is now delivering to all of Gaslight. Sandy will update the master list.
