#### STREETLIGHTS

In the last week of August all residents affected by the street light issue (households south of Browncroft Blvd.) were delivered a summary together with a ballot / questionnaire to fill out and return by September 15th. By September 13th approximately 25% were returned. We anticipate there will be more in the post office box by the deadline to tally. We also encourage residents who have not sent in their survey to continue and fill them out and send them in. The deadline was established in the hope that we would be able to publish the results in this issue of the BROWNCROFT CRIER.

The street light types listed were:

- A. Keep the existing system after repairs have been made and broken poles replaced. These would be concrete poles on streets south of Dorchester and metal arch-over poles on Dorchester and streets north of Dorchester.
- B. Newly installed replicated concrete poles and refitted harps with new underground cables.
- C. The City's 'generic system' with black fiberglass poles and high pressure sodium (HPS) lamps which give orange light.
- D. The City's black fiberglass system with mercury vapor or metal halide (white) light.

The preliminary count from the 25% sample returned to date reveals the following:

For streets which currently have the concrete poles (south of Dorchester):

78% chose system A

11% chose system B

7% chose system D

4% chose system C

For streets which currently have tall metal arch-over poles:

57% chose system B

23% chose system D

17% chose system C

3% chose system A

The most common comment entered on the ballot was that, above all, the orange lights are unacceptable. It is interesting to note that, although the city ha

introduced a new option, specifically the black fiberglass system with a white light bulb, the majority of the residents thus far on the streets which have the metal davit poles still prefer the option they chose on the 1984 petition.

A meeting with Mayor Ryan has been requested in writing and this survey will be helpful to the street light committee in representing this neighborhood's position at this anticipated meeting. We thank all who returned their ballots and encourage those who have not, to do so soon. Comments are also appreciated which clarify the choice made and designate a second choice. Also, these comments will be shared with our elected officials and city engineers.

## LEASHING THE DOG PROBLEM

The City Code says:

- ▶ All dogs must be leashed or confined to the owner's property.
- ▶ Female dogs in heat must be confined to the owner's property.
- ▶ Dogs are not allowed in public buildings, restaurants, stores or cemeteries.
- ▶ Dogs may not damage, deface or deposit waste on the property of others or on public property.
- ▶ Dogs may not annoy neighbors by continuous barking or howling.

The Animal Control Center, operated by the Humane Society of Rochester and Monroe County, is responsible for enforcing the City's rules for dogs.

If you allow your dog to break the rules, an animal control or police officer can issue an Appearance Ticket requiring you to appear at the Dog Complaint Bureau and you may be fined.

## RECYCLING EXPANDS OCTOBER 23rd -- newspapers, clear glass, & metal cans

The Rochester Recycling Revolution continues the week of October 23rd when the newspaper recycling program expands to include clear glass and metal cans.

Along with this BROWNCROFT CRIER you will find a flyer from the city outlining the steps to recycle. Please read it and participate. The expanded program begins on your regular refuse collection day.

#### REFUSE REGULATIONS

Here's a handy guide to insure collection of your household waste. If you have questions please call 428-5990.

- ..... Maximum weight limit per item, 60 lbs. bundle or container.
- ..... Metal & plastic cans or plastic bags are the only proper containers to use.
- ..... Always tie loose wood or branches. Bundles must be no longer than 4 ft.
- ..... Appliances, furniture and other bulky items must be placed between the sidewalk and curb for pick-up.
- ..... You must provide a clear 4-ft. wide path to your trash cans.
- ..... Place bulky items between sidewalk & curb on the night before your collection day.

## PAC-TAC IN BROWNCROFT

PAC-TAC stands for Police and Citizens Together Against Crime. PAC-TAC volunteers are trained by the RPD to patrol their neighborhood on evenings (7pm-10pm) that are convenient for them, at least once per month and are to report any suspicious activity to the patrol officers by utilizing a police radio which they carry. PAC-TAC volunteers patrol in teams (at least 2 adults) and are non-confrontational. They act as the eyes and ears for the Police. They are your friends and neighbors who give their time to make our Browncroft neighborhood a safer place to live. ## ADOPT-A-HYDRANT PROGRAM

If you are interested in adopting a fire hydrant nearest your home, please contact the NEAD office at 482-7320 for more information. By adopting-a-hydrant you are making sure that it is there when an emergency situation occurs.

In the summer months you monitor the hydrant by making sure all parts of the hydrant have not been broken and making sure children DO NOT open them to play with the water, which cause injury and a drop in water pressure.

In the winter months you are asked to keep the hydrant free of snow. This allows firefighters to have quick access in an emergency situation.

Monitoring a hydrant takes very little time. Resident and group participation is needed to insure proper function and access to hydrants year round.

Call 911 immediately if you see a person tampering with a hydrant. IT IS ILLEGAL FOR UNAUTHORIZED PEOPLE TO OPEN A FIRE HYDRANT.

## THE CITY'S DRUG CRIME HOTLINE 428-6000

When you witness illegal drug activity, help the police say 'No' to drugs by reporting: Suspects' vehicle license number, make and description; and / or Suspects' names, addresses and physical description. For emergencies dial 911.

The police will have all tips about illegal drug activity in the city investigated by narcotics officers. The HOTLINE operates 24 hours a day, seven days a week. Anonymous tips will be accepted.

A least 20,000 adults in Monroe County are functionally illiterate and thousands of foreign residents need help with English. Many of them cannot read want ads or job applications; cannot read simple books to children; cannot read labels on medicine bottles; and cannot read traffic signs.

A Literacy Volunteer is someone like you who wants to do something that will make a difference. You can make a difference by spending two hours a week with an illiterate adult, teaching basic reading and writing or with a foreign born resident, teaching English as a second language.

Literacy Volunteers attend a 21-hour training program for either Basic or ESL tutoring and are then assigned a student who has asked for help and been interviewed by our office.



# Here's how to get your recyclables ready for pickup.



Stack your clean newspapers in your blue box.



When it's windy, weight them down with a rock.



Rinse out your clear glass food and beverage containers. Please *do not* include colored glass, plate glass, or deposit bottles.




Rinse out all your metal food and beverage containers to remove any food residue. But leave the lids. Do not include deposit cans.



Put your newspapers, clear glass containers, and metal cans in the blue box.



Take the blue box to the curb on pickup day when it's over half full.



Please remember: don't include plate glass, window glass, ceramics, laboratory glass, crystal, magazines, other kinds of paper, plastic bags, or deposit bottles and cans.
