- Ann made a motion, second by Adam to approve budget of \$400 for pilot program of hospitality bags – All were in favor with the exception of Holly.

School #46 – Ann – 80 books were purchased for 40 new students – thank you notes will be coming.

Beautification – Cassy – 9 U of R students participated – did not get as much done as in previous years – BNA resident Carol Bassett would like to donate a bench – she has been invited to a Rose Garden beautification committee meeting.

Zoning – Cassy – City to vote soon – still working on proposed code changes- City wants to increase density – improvements in City infrastructure needed to enable increase in density.

Crime – Holly – lengthy discussion on recent neighborhood crimes including stolen cars, multiple smashed in car windows, people trolling our streets/driveways - John had a face to face incident with a suspect at his home. Discussed reinstating Pac-Tac for which there are training sessions available, neighborhood watch, crime prevention officer to attend BNA meetings, block chain notification initiative. Bob stated our website has a "neighborhood watch" & prevention links.
