Public meeting space – 46 school needs application for requested dates – Ann to submit date of May 13 with May 20 as backup date – Ark of Jesus was unavailable for tonight's meeting.

March General Meeting with speaker – suggestions included reps for various PTAs, urban planning, general academic speaker.

Garage Sale – organizing committee still not established – list of duties include: porta potty, permit for school, insurance, signage, advertising, etc. - suggest sending out BNA Announce asking for volunteers for specific duties to come to next meeting in February. If no committee established the garage sale this year may not be a BNA sanctioned event.

Newsletter – Cassy reported there has been input from street reps to have the Crier be available only online or a combination of online and hard copy. After discussing the pros and cons of each, it was determined hard copies reach the broadest audience.
